A large number of prospective investors, office bearers of different chamber of commerce and industries of Sri Lanka, academicians, members of Federation of Chamber of Commerce and Industries of Sri Lanka, SAARC Women Entrepreneurs' Council, Prominent Media Houses and their representative attended the program.

The program was divided into: Formal presentation, open session for open discussion and clarification of any issue to the audience followed by cocktail and dinner Reception.

In the beginning, H. E.
